In a major development, the Framework Agreement on establishment of the International Big Cat Alliance (IBCA) has officially come into force. From 23rd January, 2025, the IBCA and its Secretariat have become a full-fledged treaty based inter-governmental international organization and international legal entity.

To this effect, the Ministry of External Affairs (MEA), Government of India (the Depository of the Framework Agreement) has confirmed that five countries - Republic of Nicaragua, Kingdom of Eswatini, Republic of India, Federal Republic of Somalia and Republic of Liberia - have deposited the instruments of ratification/acceptance/approval, under the Article VIII (1) of the Framework Agreement.

The IBCA was launched by the Prime Minister Shri Narendra Modi on 9th April,2023, during the event 'Commemorating 50 years of Project Tiger'. The Union Cabinet, in its meeting held on 29th February 2024, approved the establishment of IBCA with headquarters in India. It was launched with the aim of conservation of seven big cats - Tiger, Lion, Leopard, Snow Leopard, Cheetah, Jaguar and Puma — with membership of all UN countries/the range countries harbouring the said species and non-range countries where historically these species are not found but interested to support big cat conservation.

The IBCA was established by Government of India, through the nodal organisation viz., National Tiger Conservation Authority (NTCA), Ministry of Environment, Forest & Climate Change (MoEFCC), vide order dated 12th March, 2024. The primary objective of IBCA is to facilitate collaboration and synergy among stakeholders, consolidating successful conservation practices and expertise to achieve a common goal of conservation of big cats at global level. This unified approach, bolstered by financial support, aims to bolster the conservation agenda, halt the decline in big cat populations, and reverse current trends.

The rules are based on the principle of extended producer responsibility (EPR) where producers of vehicles are given mandatory EPR targets for scrapping of end-of-life vehicles. The rules cover all types of transport and non-transport vehicles, except agricultural tractor, agricultural trailer, combine harvester and power tiller.

Further, the Central Zoo Authority has issued guidelines to zoos time to time for proper hygiene and health of all captive animals in zoos.

Nano bubble technology is a method of water treatment that uses tiny bubbles to improve water quality. The important ecological benefits are to <u>remove contaminants, increase dissolved oxygen</u> <u>content</u>, help in the removal of phytoplankton (algae), reduce biofilm, and ultimately improve the properties of water suitable for aquatic animals. The nano bubble technology can lead to a more homogeneous distribution due to the minuscule size and persistence of the bubbles in the water

bodies. On the other hand, traditional systems may exhibit less uniformity in distribution, which can result in variable oxidation and disinfection performance across the water volume.

R. 703 (E) dated 12-11-2024 under section 25(1) of the Water Act] have been issued to exempt white category of industries completely from consent mechanism and other categories from Consent to Establish if the project or activity has obtained environmental clearance under the Environmental (Protection) Act, 1986. In view of the above, the project / activities requiring prior EC as per the Environmental Impact Assessment Notification, 2006 (as amended from time to time) under Environment (Protection) Act, 1986 are exempted from obtaining previous Consent To Establish (CTE) separately.

The Department of Fisheries, Ministry of Fisheries, Animal Husbandry and Dairying, with effect from financial year 2018-19 has been implementing Fisheries and Aquaculture Infrastructure Development Fund (FIDF) with a total **fund size of Rs 7522.48 crore**. FIDF inter-alia provides concessional finance for development of various fisheries infrastructure facilities to the Eligible Entities (EEs), including State Governments/Union Territories and State entities for development of identified fisheries infrastructure facilities. Under FIDF, the Department of Fisheries, Government of India provides interest subvention up to 3% per annum for providing the concessional finance by the Nodal Loaning Entities (NLEs) at the interest rate not lower than 5% per annum.

The Department of Fisheries, Ministry of Fisheries, Animal Husbandry and Dairying since the inception of the Fisheries and Aquaculture Infrastructure Development Fund (FIDF) in 2018-19, has accorded approvals to a total of 64 number of fisheries infrastructure development proposals of Governments of Tamil Nadu at a total outlay of Rs. 1574.73 crore with project cost restricted for interest subvention at Rs.1336.73 crore. The National Bank for Agriculture and Rural Development (NABARD) being the Nodal Loaning Entities (NLEs) for State Implemented projects, has sanctioned loan amount of Rs. 1314.73 crore to the Government of Tamil Nadu and out of this, an amount of Rs. 956.05 crore has been disbursed so far to the State Government for implementation of the approved projects under FIDF. The Government of Tamil Nadu reported completion of a total of 47 projects while 16 projects are in progress and one project has not yet commenced by the State Government. The Central Approval and Monitoring Committee (CAMC) of FIDF monitors regularly the progress of the projects approved under FIDF and National Fisheries Development Board (NFDB) as the Nodal Implementing Agency (NIA) of FIDF conducts the desk studies and need based field inspections of approved projects to ensure the timely completion of approved projects. Besides, the Department of Fisheries, Ministry of Fisheries, Animal Husbandry and Dairying also reviews the progress of approved projects to ensure the timely implementation.

NBM provides assistance to both the Government & private sectors for the propagation and cultivation of bamboo in non-forest land, bamboo treatment, establishment of markets, incubation centers, value added product development & processing and development of tools & equipments. The funding pattern is 60:40 between Centre and State Government for all States except NE & Hilly States, where it is 90:10 and 100% in case of Union Territories/Bamboo Technology Support Groups (BTSGs) and National Level Agencies.

No specific census/survey of landless farmers has been conducted by this Ministry. Therefore, the exact number of landless farmers and farming on crop sharing basis with land-owners in the country is not available. However, number of wholly leased-in operational holdings/landless farmers in the country as per the latest Agriculture Census 2015-16 is 5,31,285.

Agriculture being a State subject, the State Governments undertake implementation of agricultural schemes/programmes for the welfare of farmers including landless farmers and the Government of India also supplements these efforts through implementation of various central sector/centrally sponsored schemes/programmes. Among these, the schemes which specifically cover landless, tenant farmers and sharecroppers are the Pradhan Mantri Fasal Bima Yojana (PMFBY) & Restructured Weather Based Crop Insurance Scheme (RWBCIS) and Kisan Credit Card (KCC) scheme.

Under the Kisan Credit Card (KCC) scheme, farmers receive KCC loans at a subsidized interest rate of 7%. To facilitate this, an up front interest subvention (IS) under Modified Interest Subvention Scheme (MISS) of 1.5% is provided to financial institutions. Additionally, farmers who repay their loans promptly **receive a 3% Prompt Repayment Incentive** (PRI), effectively reducing the interest rate to 4% per annum. The benefits of IS and PRI are available for loan limits up to Rs.3 lakhs. However, if the short-term loan is taken for allied activities (other than crop husbandry), the loan amount is limited to Rs.2 lakhs only.

So far, 24.74 crore Soil Health Cards(SHC) have been generated across the country and funds amounting to ₹1706.18 crore have been released to various States/UTs. Till date, 8272 Soil Testing Labs (1068 Static Soil Testing Labs, 163 Mobile Soil Testing Labs, 6376 Mini Soil Testing Labs and 665 Village Level Soil Testing Labs) have been established across the country.

The Soil and Land Use Survey of India, a subordinate office under the Ministry of Agriculture &

Farmers Welfare, organizes short-term training courses (3 days) on topics such as the application of soil databases through Geographic Information System (GIS), Soil Health Management, Integrated Watershed Management (IWMP), Geo-Spatial Technology for Natural Resources Management, and Soil Survey & Mapping. These training programs are designed for officers and officials from various user agencies in different States and Union Territories.
